# JOHN ARKINSTALL STATE OPEN TEAMS – 2022 NSWBA QUALIFYING EVENT SUPPLEMENTARY TOURNAMENT REGULATIONS

This competition is conducted under the Laws of Duplicate Bridge 2017, supplemented by the Tournament Regulations of the NSWBA as amended and these Supplementary Regulations. In case of conflict between these Supplementary Regulations and the NSWBA Tournament Regulations, the Supplementary Regulations shall apply.

#### 1 The Event

- 1.1 The event will be held online using the RealBridge platform over four nights, as scheduled in the official NSWBA Program. All players on RealBridge should have working video and audio connections. Players may only turn off their camera with the permission of the Director.
- 1.2 The event will be run as a full round robin of 11 x 10-board matches played as follows:

Week 1: 4 x 7 boards

Week 2: 4 x 7 boards

Week 3: 3 x 10 boards

Week 4: 8 x 3 boards, completing the 8 partial matches played in weeks 1 & 2.

- 1.3 Match scores are converted to VPs using the appropriate WBF continuous IMP to VP conversion scale. (Interim scores posted for weeks 1 & 2 are based on the 7-board scale.)
- 1.4 The official scores are those posted on the NSWBA website.
- 1.5 Yellow systems will not be permitted.

#### 2 Tie Breaks

Ties will be broken, in order, as follows:

- i) The team with highest number of "wins" (with an exact draw counting as a "half-win") will be ranked highest;
- ii) In the case of a two way tie, the team which won the head-to-head encounter will be ranked higher;
- iii) Net IMPs
- iv) The team with the best result against the highest placed of the other teams will be ranked highest if still tied, the process will be repeated against the 2<sup>nd</sup> highest, 3<sup>rd</sup> highest, etc.

### 3. Fees

- 3.1 The entry fee as specified must be paid in full before play begins.
- 3.2 There are no subsequent entry fees for teams that qualify to the State Final or the NSWBA Metropolitan Teams Final (Jacaranda Teams Congress).

#### 4. Score Correction Period

The correction period ends at midday on the Wednesday immediately following each session.

### **5 Substitutions**

Substitutions are to be in accordance with the standard NSWBA substitution regulations.

### 6 Qualification to Subsequent Stages

- 6.1 The two highest placed eligible teams will qualify to the Finals of the John Arkinstall State Teams, to be held at the NSWBA on 9-11 December, 2022.
- 6.2 The next highest ranked team eligible will be offered free entry into the NSWBA Metropolitan Final (Jacaranda Teams Congress) on 16<sup>th</sup> October.
- 6.3 Any offer not accepted devolves to the next placed team, but no offer will be made to a team finishing below equal fourth place (before tie breaks).

## 7 Augmentation for Subsequent Stages

- 7.1 All requests for augmentation should be emailed to Warren Lazer, Chairman of the NSWBA Events Committee, at <a href="mailto:events@nswba.com.au">events@nswba.com.au</a>
- 7.2 No team may augment beyond a maximum composition of 6 members.
- 7.3 All augmented players must be eligible to participate in a Metropolitan Zone club qualifying event.
- 7.4 No member of a team offered a place in the State Final via the NSWBA's Direct Qualifying Event may be augmented.
- 7.5 For teams proceeding to the Metropolitan Final, the request for augmentation must be received before 2<sup>nd</sup> October, 2022. For teams proceeding directly to the State Final, the request for augmentation must be received before 25<sup>th</sup> November, 2022. Permission to augment after these dates may be granted by the NSWBA Events Committee in exceptional circumstances.
